Terms and Conditions of Purchase

1. **Price Firm:** The price at which Cytec agrees to purchase the materials is the price stated on the Purchase Order.
2. **Quantity Variations:** Any variation from the quantity stated on the Purchase Order shall be subject to approval by Cytec's Purchasing Agent.
3. **Delivery Commitments:** The supplier shall notify Cytec's Purchasing Agent if the supplier cannot meet the delivery terms stated. Cytec reserves the right to cancel the Purchase Order if the delivery date is not acceptable.
4. **Preservation, Packaging and Packing:** All material shall be packaged to ensure adequate protection against dust, moisture and physical damage during shipment from the supply source to Cytec.
5. **ESD Sensitive materials:** ESD components must be clearly labeled and packaged according to ANSI/ESD S20.20.
6. **Shelf Life:** All items that have a shelf life must have at least 80% shelf life remaining upon receipt.
7. **Warranty:** All parts supplied must be guaranteed to be new, unused and original in packaging and origin unless otherwise stated on the purchase order. All materials shall be free from defects in design, content, workmanship and construction. Cytec reserves the right to have the supplier repair or replace defective materials or refund all or part of the price of the materials.
8. **Certificate of Compliance:** A Certificate of Compliance is required for all products.
9. **Conflict Minerals:** In compliance with section 1502 'CONFLICT MINERALS STATUTORY PROVISION' of the Dodd-Frank Wall Street Reform Act, Cytec Corp. does not accept parts manufactured with tin, tantalum, tungsten or gold mined in Democratic Republic of Congo or adjoining countries.
10. **Counterfeit Parts:** The supplier shall have controls in place to ensure that the goods delivered are and only contain materials obtained directly from the original manufacturer, an authorized distributor or an authorized after market manufacturer and do not contain counterfeit items or suspected counterfeit items.
11. **Calibration:** Calibration shall be tested with standards & equipment calibrated with traceability through the National Institute of Standards & Technology (NIST) or other national measurement institutes (NMI) that are signatories to the CIPM Mutual Recognition Arrangement. Calibrations should comply with ISO 9001: 2015 as applicable. The Supplier shall provide a test report/calibration certificate for each item calibrated. Each test report/calibration certificate shall contain as a minimum:
 - a. Description or identification of the item.
 - b. List of standards used for traceability.
 - c. Date of calibration.
 - d. Test results/values.
 - e. Test report/calibration certificate number. When an instrument has been adjusted or repaired, the calibration results before and after adjustment or repair shall be reported.
